## **Looking to The Future**

In April 2023 Archbishop Nolan launched his "Looking to the Future" initiative. This was intended to look at how the Archdiocese of Glasgow could continue to provide pastoral care in the future, considering the challenges of falling attendance, financial constraints and fewer priests. Changes would have to be made and hard decisions taken. This has been publicised in the Flourish and in past bulletins. For Holy Cross this means looking to our future within the new South Deanery.

### **Pathways to Change**

Change is never easy. Change may mean letting go of something we value to embrace something of greater importance or value. The motivation behind any change is key.

From earliest times adapting to different situations has been a crucial part of the Church's work of evangelisation. Service, in the work of proclaiming the gospel, is our mission as a community of faith. Anything which may hold us back from that fundamental vocation needs to be reviewed and if necessary reformed. Our goal in revising our parish structures in the Archdiocese is the creation of vibrant faith-filled communities that nourish the faith of the Church and offer witness to the gospel and its values. Sacraments, liturgy, community, care for the poor, are at the core of who we are as a Church, rather than buildings or boundaries. We aim to look to the future, while being faithful to the past.

# As we look to the future how do we best use the resources that we have before us in fulfilment of our core mission?

Some introductory comments may be helpful.

### On which parishes should close.

- There is an important distinction to be made between the closure of a church building and the
  merger or realignment of a parish. In most cases parish boundaries will be realigned so that the
  pastoral care of the community is maintained. Parish buildings will be dealt with separately.
- It should be noted that where a building is sold the financial benefit to the Archdiocese of Glasgow is limited. The assets of the parish follow the parishioners to their new parish. Where for pastoral reasons a parish is divided up between more than one parish, the assets of the previous parish will be divided in the same way.
- The assessment of which parishes should close should be based on the provision of pastoral care, rather than the history of a particular church or the listing of the property.
- The listing of a given church is offered for information. This should not be taken to mean that a particular building should be considered as outside the scope of this discussion.

#### On numbers of clergy

- The number of clergy is projected to fall sharply over the next few years. We have given an indication of how this may affect your deanery.
- In the figures quoted where religious congregations are concerned we have allowed for 1 priest in our calculations.

To illustrate the actual issues facing the South Deanery it is useful to look at what is currently available in terms of the number of priests and parishes and what is projected the situation will be in 5 years time. The table below illustrates this.

This reduction in the number of priests should not be looked at in isolation. The number of practising Catholics who attend church has been falling for some time and this does affect how many will come forward to accept a vocation in the priesthood. This is illustrated by the numbers in the table below.
